Introduction

Bowman Performance Consulting (BPC) is a welcoming and intersectional space where contributions from the seen and unseen are important aspects of our seven directions and seven generations work. Who we are on the inside is what we bring in a good and respectful way as we aspire to be Good Relatives in academia, education, community contexts, or any spaces we are invited into. Our intention is that when we arrive, we are there as healthy partners, are of good mind and spirit, and are present, mindful, and open and act in humble and appreciative ways as we work in service of others. Our service is grounded in origin stories and using the wisdom of our Ancestors to restore balance as we walk together in this world. BPC values and honors the timeless Indigenous knowledge and experiences of generations before us, those that walk with us now, and those that are yet to be born. This knowledge and our sacred responsibilities are given to us by traditionalists and elders of our various communities as we uniquely express into the world what is in our Good Medicine bundle and what we learn through ceremonies, culture, and language and apply every day in practice. Our traditional foundation gives us roots to the past, present, and future so it is with this Indigenous traditional framing that we offer a living document (not exhaustive) of resources that speak to us as humans and our work on behalf of the seen and unseen, human and non-human relatives on Mother Earth.

Given this quick overview of BPC's core philosophy and values, we frame the resources in this document as helpful guideposts to more inquiry, more fire in your own sacred work, and more healing on the pathway you are on or that you are bringing your families, communities, and professional networks on. Culturally Responsive Evaluation (CRE), Culturally Responsive Indigenous Evaluation (CRIE), and Culturally Responsive and Equitable Evaluation (CREE) as Good Relatives are all contemporary terms created in response to one source: colonization. Through CRE, CRIE, CREE, and other anti-racist, social and human justice, and equity resources and activities, we strive to stand in the place and be the visible voices to represent places, topics, and spaces (physical, literary, virtual, mind, heart, etc.) that our Ancestors cannot. Tribal sovereignty is a unique aspect of more than 1,204 federally or state recognized Native Nations on Turtle Island (North America), and many more Indigenous communities exist that we honor as well as they find ways to restore their treaty, legal, and political rights on a global scale (see also <u>United Nations Permanent Forum on Indigenous Issues</u> for information and current activities).

BPCs staff and families represent generations of the few of the Indigenous survivors of colonization, and therefore, BPC will not be quiet or still about our liberation and survivance from the oppressors and the settlers who benefit from colonization to this very day.
